MEET THE NEIGHBORS by Jan Peranteau

Cats have not always been a part of Gail Collins' life. "My first cat adopted me. When I first got married, a cat came to the door. Now my limit is six cats at a time." Working on the Monticello Park Neighborhood Association Board, Collins heard many complaints about stray cats in the neighborhood. She heard another board member, Tony Sanchez, complaining about cats yowling at night, and the perfume of cat spray in yards.

On evening walks, she spotted houses that had a passel of cats hanging about the yard. She decided to do something. She enrolled in a feral cat workshop and met Kay Keane. They began a project that would spay, neuter, and return two hundred cats in the Jefferson neighborhood and one hundred cats in the Pasadena neighborhood. Working alone mostly, she trapped, neutered and returned sixty-six cats in the Monticello neighborhood in 2009. In 2010, both of her parents died within months of each other, and she has captured, spayed, and returned twenty-nine cats. What is amazing about these numbers is that the sixty-six cats in 2009 came from ten households. The twenty-nine cats came from five households. She recently inherited a big dog named Sugar from her deceased parents, so Collins is busy. Sugar lounges about on a couch and is adjusting to six cats in the house. The cats are adjusting to Sugar, especially

Peanut, a fifteen year old white cat with slanty eyes. He regularly pees on Sugar's bed just to show his displeasure at the situation. But Collins and Sugar are patient. They pad the bed with extra towels that can easily be washed.

You might think that six cats and one dog would be a stinky affair. But not so—there is no animal odor. Collins attributes this to clumpable kitty litter.

But why so many cats in the neighborhood? Collins said, "A female cat can produce eighteen kittens in a year. So with unfixed females, the numbers multiply quickly." Kind-hearted people feed them." Sometimes it is at the back

door and sometimes people travel to the location of feral cats to feed. She described a woman, "Pat" who rides the bus, buys a bag of cat food at HEB and walks the neighborhood feeding cats at 11:00 p.m. at night. Collins described this as scary. "You're walking onto people's property at 12:00 o'clock at night. You don't know if you will be shot."

PRESIDENT'S MESSAGE

The heat of summer and a birthday party for a ninety-five year old drew me to the northern part of the nation recently. My travels took me Minneapolis, North Dakota, and the Black Hills of South Dakota.

While in the Black Hills, we visited Deadwood. We were curious about the town not only because of the HBO series, but due to the fact that my children's great-great grandfather owned a saloon in the old-west town. We were off on a fact finding mission and hoping to get a glimpse of the actual site of this little slice of a rollicking history.

We never did find the location of the bar nor of the gravesite. It seems that all of the Catholic burial records burned in 1934. The great fire of 1879 took down the majority of homes and businesses in Deadwood. Sturdy brick and stone buildings such as the Bullock Hotel and The Gem saloon were built in 1905 and remain today. Do those names sound familiar? They are still as interesting and beautiful as they appear in the series.

The reason I share this with you is that in the middle of the historic Main Street, we came upon a building completely out of sync with the rest of the street. It was in the post-World War II style and was completely covered in stucco. It appeared as if it had been lifted up from Los Angeles or anywhere along the old Route 66 and planted on this main corner of Deadwood. It was like a meatball in oatmeal, orange juice and toothpaste. Lebron James and any other basketball team--it just didn't belong! My travel companion asked how in the world this could have happened in a historic district. My answer was that not all historic districts are the same.

And that's why I bring this little story to your attention. The historic districts in San Antonio exist for an important reason. The intrusion of architectural styles and design elements out of sync with a neighborhood destroys the flavor of that very neighborhood. While we have many different styles. sizes, and people; there is a flavor to our neighborhood which must be preserved. The HDRC works hard each week to ensure that the style and flavor of an area remains. We are embarking on another round of Neighborhood Beautification awards and the two go hand in hand.

During the last contest period, only one neighbor completed an application for the beautification award. All through Monticello Park, neighbors are improving landscapes and exteriors of homes. The application for this contest is included in this month's newsletter. Please consider applying for the award which will help offset the expense you have undertaken in order to improve the outside of your home and grounds and ultimately, the beauty of our neighborhood.

Community committee working toward school improvements

Trustees are expected to decide in August whether to call for a Nov. 2 bond election to benefit District schools. Helping to explore this idea is a 35-member community-based committee which has been meeting since late May to discuss District needs and help determine the details and priorities for a possible bond package.

Parent and State Rep. Mike Villarreal and parent Celina Peña are co-chairs of the committee whose members were appointed by Trustees - five each from every School Board district - and made up of residents, parents, alumni, past committee members and employees. The committee has reviewed the District's financial information, tax impact scenarios, and the long-range strategic plan, and also have toured facilities to help guide their recommendations. The co-chairs presented an update on the committee's work at the June 21 School Board meeting, and reported that members recommend a \$502 million bond referendum for November. But first, there are still items to be considered including tax impact and bond package details. The committee will provide final recommendations to the School Board in late July.

The committee's work follows approval by the School Board last April to move forward with the first phase of implementation of the long-range restructuring plan, which also was developed by a community-based committee. Under Phase I recommendations, all schools would receive safety and security and technology improvements, several schools would be significantly renovated into 21st century instruction environments, and high schools and middle schools would receive career technology program enhancements.

The project began in earnest with Collins handing out flyers in the neighborhood saying that cats could be spayed, neutered and returned. If someone needed help and didn't have the money to pay, a telephone number was given. Cats would be given the following:

- 1. Spay or neuter
- 2. Rabies shots
- 3. FNRCD-a major illnesses and distemper shot
- 4. Ivermectin-Drops in the ear for ear mites and other infections
- 5. Ear tip cut-on left ear to identify cats that had been treated.
- 6. Penicillin

The bottom line is that cats will be treated even if owners do not have money to pay. If pet owners or feeders can pay, the charge is \$10.00 per cat.

Collins emphasizes that euthanasia does not work because you can never catch all the cats.

Collins concludes by saying "I am passionate about spay and neuter. I am passionate about returning feral cats to their home environments. I am passionate about the availability of low-cost services." She says, "If you need help, call me." Her number is 735-9966.

Collins also made a plea for help. "We need volunteers who will help with this project. If you cannot help with the trapping of cats, maybe you could give a donation to MPNA for this cause." Currently, the neighborhood association has re-reimbursed Collins for the cost of spaying and neutering the animals. But Collins pays much of the wellness care for the animals she picks up. Please consider lending a helping hand to this cause.

Collins gets a little teary when she talks about Rocky, one of the latest rescued cats. "Kay Woods and I bottle fed four kittens that had no mother. We were able to give away all the cats to homes, but then I missed the kitty. We paid the new owners \$25 to bring him back." Life is always bustling at the Collins house. Her heart and home are a haven for her animals. The Inn is full, so don't get any ideas about dropping off strays. "I've got all that I can care for. But I will help people who need assistance with cats."

Beautification Project Rules

You must abide by the following rules to be considered for the reimbursement award. A committee will make the final decision as to which household will receive the reimbursement award.

Your full application must be submitted to a board member by Saturday, November 6, 2010. Applications must include receipts, work orders, contracts or photocopies of the same. The MPNA will reimburse you up to \$500 for your project. If your cost is less than \$500, you will be reimbursed up to the amount of your cost.

Some store receipts do not give details of items purchased. Please list your purchases on a sheet of paper. You must turn in your receipts or copies along with this list.

The project must be able to be seen by anyone who stands on the street. Your undertaking should take place in the front of the house if you live in the middle of the block. If you live on a corner, the project can be on either the front or the side of the house or yard.

You must submit a "b efore" and an "after" photo of your project.

All repairs/maintenance and changes, including window repairs and landscaping, must be submitted to the Office of Historic Preservation for approval. Check with the Office of Historic Preservation before you begin any work and make sure to obtain a Certificate of Appropriateness. You must submit a copy of the certificate of appropriateness as part of the application. The Office of Historic Preservation is located at 1901 South Alamo. The phone number is 215-9274.

Some types of work need a permit from the city. Check with the Office of Planning and Development before you begin any work and obtain a permit if needed. If a permit is needed from the city, you must submit a copy of the permit as part of the application. The Office of Planning and Development is located at 1901 South Alamo. The phone number is 207-1111.

If you were not awarded a reimbursement for your project the first time you applied, please ensure that you have checked the appropriate space on the application that this is your second time to apply.
