#### MEET THE NEIGHBORS by Jan Peranteau



Earline Valdez and Sandee Gibson wait at the Monticello Park bus stop for their next exciting bus ride. Step back in time and ride the bus for a quarter. You must be 62 years old and have a Reduced fare I.D. Now, laugh at the price of gas at the pump. Sandee and Galen Gibson decided to try the bus lines about a week ago and found it to be a real adventure. "We got on 91 and rode to town in fifteen minutes," Sandee Gibson said.

Another neighbor, Earline Valdez, gave advice. "Make sure you don't sit by the window. I sat by the window once. A drunk went to sleep beside me and I had a hard time getting out." Valdez often rides the bus to Southwest Craft Center where she takes weaving classes. She also explained,"I used to take the 509 to Incarnate Word University. I volunteered at the Retirement Center there." When asked how long it took, Valdez replied, "Oh, it was less than thirty minutes. I'd say between fifteen and twenty-five minutes. "

Valdez said, "Usually, the talk is friendly." She remembered one such conversation. "A young man sat beside an older woman who was all dressed up. She had on red gloves. The young man kept saying, 'you're such a nice grandma." Sometimes though, the people are not so nice. She remembered one of the colorful neighborhood characters who ranted on and on. "But the bus gets you where you want to go."

One morning, Gibson and Jan Peranteau set out for the Pearl Brewery on Broadway. Since this is a trendy spot for shopping and eating, and the goal was simply to get there and get back home. The trip to the former brewery took about twenty minutes including a transfer at Five Points. Transfers for seniors are seven cents. Peranteau and Gibson got there, crossed a parking lot, got a catcall or two, and headed for the Twig Book Store. The two visited the cooking store, Melissa Guerra's Tienda de Cocina. Finally, the duo rounded out the shopping venture at Adelante, a children and women's clothing store. Since the farmer's market is not open n weekdays, Peranteau and Gibson decided to dine at Il Sogno, an upscale restaurant where the two sat at the bar and watched the chefs preparing food.

On another day, Public Information Coordinator for Via Metropolitan, Andy Scheidt, shared information about the Via Bus System. He said, "We have ninety-one bus lines that operate seven days a week. The hours of operation are from 4 a.m. to 1 a.m. We go out as far as Loop 1604 and offer a variety of services." He said, "Categories of service include frequent, metro, express, skip, and streetcar as well as Via Trans for special needs, special event, and vanpool service."

#### PRESIDENT'S MESSAGE

Thanks to all who attended the last General Assembly. We heard a very informative program from David McCary with Solid Waste Management. We learned about the many changes that the city has implemented and some of the rule changes which have taken place. Yet, with the recent brush pick-up, many still included large trash items as in the past. These neighbors were dismayed to discover that those items were not picked up. All should remember that neither trash nor brush is to be left in the sidewalk area except on the dates of scheduled pick-ups. The large trash item pick-up will take place later in the year and will be announced ahead of time. At that time, no brush will be picked up, only trash.

The neighborhood association has been busy this month with a couple of issues. Our advice was requested by the city concerning the small island on Kampmann Boulevard across from Thomas Jefferson High School. We are concerned for the future of this island and the surrounding campus, and our response to the city is included in this newsletter on page 10 and 11. We have registered our rejection of the request as it stands, and the Jefferson Neighborhood Association has done the same.

Our first social event was held at the end of February. The MPNA Board decided that to encourage membership and neighbors getting to know one another, we would schedule a social event on the months that we do not hold a General Assembly. If this is any indication, we are off to a good start. If you missed this one, don't miss the next one on April 22. See the last page for details.

We continue to monitor the BRT situation and plans for the bus stop at the end of Mary Louise Drive. While our input has already been made, we are keeping in touch with our Councilman and the city concerning the plans as they unfold. Stay tuned, if we have another call to action concerning this, you will be the first to know! We are also staying on top of the new bills presented in the Texas Congress in regards to electronic billboards. Your help is needed! See page 14 in this newsletter.

Our next General Assembly is Monday. We will be hearing an update on the alley maintenance currently going on in Monticello Park. Many have been concerned that alleys are being closed, but in fact, they are being upgraded. Come listen to the progress and the plans.

# City of San Antonio

#### Key Points...

- Changes are effective February 17, 2011

- Signage must be weatherproof and not less than 3"x4" with letters not less than 2/3" in height
- Requires property owner complaint to trigger enforcement call 207-7273 (SAPD)
- Does not apply to federal, state or municipal government and any religious, political or charitable advertisements or handbills

### Handbill Distribution on Public and Private Property

An update to the City code

Gives citizens an avenue to restrict the distribution of advertisements on their property where "No Solicitation"-type signs are displayed in a conspicuous place upon or near main entrance to property

#### Chapter 21-3 Advertising on Public and Private Property

- a. It shall be unlawful for any person to paint, print, stamp or indent letters, words or figures, on any fence, tree, post, building, wall, sidewalk or bridge in this city, or to post bills on any fence, building, walk, sidewalk, or bridge in this city, without having first obtained the consent of the parties owning or controlling the same.
- b. It shall be unlawful for any person to distribute or cause to be distributed, deposited, placed, thrown, scattered or cast any handbill upon any private property if requested by anyone thereon not to do so, or if there is placed on such premises in a conspicuous place upon or near the main entrance to the premises, a weather-proof card, not less than three (3) inches by four (4) inches in size bearing the words "no trespassing," "no peddlers," "no advertisements," "no solicitation," "no handbills," or any similar notice indicating in any manner that the occupants of such premises do not desire to have any such handbills left upon their premises. The letters on such cards shall be not less than two-thirds (2/3) of an inch in height.
- c. This section does not apply to any department, branch or agency of federal, state, or municipal government and any religious, political or charitable advertisements or handbills.

#### Now reporting graffiti is just an app away

Reporting graffiti in San Antonio just got a touch easier. The City's Graffiti Abatement Program has teamed up with App-Order.com to create "mySanAntonioTX" smart phone application that will allow residents with Android phones to send real time graffiti information and photos to the department.

Using a built-in global positioning system the application will attach a **loc**ation to the picture and send the information to the Graffiti Abatement Program. The **electronic** submissions will then be routed to the appropriate City staff or outside agency. Residents can also choose to receive updates on the status of their request.

Residents with iPhones are expected to be able to obtain the "mySanAntonioTX" within the next six weeks. For more information on this new program, call Lisa McKenzie, graffiti abatement coordinator, Code Enforcement Services Department at 207-5430.

Regular bus fare is \$1.10 per ride with 15-cent transfers. The bus service offers free information about individual bus routes. For customer service call 362-2020. Representatives will help people plan their bus trips or one can go on line at <a href="www.viainfo.net">www.viainfo.net</a>. The Crossroads bus terminal and Park and Ride is the place to obtain a reduced fare I.D. and monthly passes as well as one day passes and semester passes for students riding the bus. These vary in price from \$30 for a monthly pass to \$35.00 for a semester pass.

Scheidt said that all buses are equipped with wheelchair access. The bus driver assists persons with wheelchairs to be safely secured in the bus. He also said that all buses are cleaned on a daily basis.

Finally, Scheidt spoke about those unruly riders who sometimes make a bus ride difficult. "We now have rules for bus travel. Theses rules are posted inside the buses. If a passenger is breaking the rules, he or she can be put off the bus. The police can be called if necessary."

When asked about improvements in the VIA system, Scheidt said, "We have increased our alternately powered vehicles. We now have thirty hybrids and four buses that use compressed natural gas. We will be adding a few all-electric buses to the fleet of 446 buses already in existence." With service area covering 1,226.07 square miles, why not give bus riding a chance and sit back and enjoy the ride?







NY COSADANY METROS OURS GAID COMMERCADOUR

The following response was formulated by the MPNA Board and sent to the city in response to the city's request for our opinion of the possible destruction of the island on Kampmann Boulevard and the closing of Kampmann Boulevard on the western side of the island:

The board of Monticello Park Neighborhood Association objects to this proposal for the following reasons:

We have not yet seen a master plan. Our vision and approval cannot be made with knowing what your vision is for the site. As shown in the attached photos, different from yours, the site does not appear closed, vacant, and abandoned. It is a neighborhood pocket park in need of some loving attention by the neighborhood. Please notice the other two pocket parks, Monticello Park (at the corner of Kampmann Boulevard and Club Drive) and the park at the other end of the neighborhood (corner of Vollum and Fredericksburg). The Near Northwest Community Plan, Action Step 6.1.1 states "Have each neighborhood association take an inventory of potential pocket park opportunities among vacant properties within their boundaries and work to adopt these properties as parks." We have had a hand in each of the park projects including the landscaping ideas along the Fredericksburg corridor.





This pocket park is not just a part of the streetscape of a neighborhood. It is a feature of a historic district. We are mindful of any changes made to the features visible from the street throughout our district, this included. Especially in a historic district, certain historic views of National Historic Landmarks should be protected, i.e. the view down Furr Drive of the domes, and the view across Kampmann from Donaldson. I am including an old postcard which says it all in our estimation.

The park is also part of the 100-year flood plain. Additions to the campus should certainly be aware of this, and substantial changes would likely be problematic for all involved.


Recent history has seen the renewal of the walkability of Monticello Park. Closing the western side of Kampmann Boulevard will interfere with the route taken by many neighbors every evening. While other urban neighborhoods (Alta Vista, Beacon Hill) have added greenspace and walking trails, this would likely be a step for us in the opposite direction.

Although Kampmann Drive would not be completely closed, the proposed closure on the western side of the park would force drivers coming from the west on Donaldson Avenue to make not just a sharp left turn, but a more than ninety-degree angle to maneuver onto Kampmann Boulevard. Nearly all of our neighbors use the western branch of Kampmann to return to Monticello Park from West Donaldson.

We understand the issues of additional space being mandated by new state regulations. We appreciate the challenges facing the high school. We are in complete support of the school, working with them on issues that face any high school, cooperating with them on traffic issues and students moving through our community to get to school. We provide at least one scholarship per year to a deserving senior at Thomas Jefferson High School. But we do not appreciate that this proposal will add any substantial addition to the campus. Several sites around the school seem more appropriate for expansion and are not included in a historic district.

We must respond with a denial of approval on this proposal. We have also taken this proposal as a call to action on the attention to this well-regarded part of our neighborhood.


You keep all of the money from the sales of your booth.

#### A CALL TO ACTION!!!

#### Here is what is at stake:

SB 971 would allow digital billboards inside Texas Cities and ETJs. As you know, several groups fought the proliferation of these billboards for two years, and the City Council did not extend the pilot program. This bill would allow billboard companies to put up additional billboards that would be used for emergency/amber alert systems when not used for regular advertising.

Below is the rationale for opposing this legislation:

VOTE NO TO STATE AND FEDERAL MANDATES

TO ERECT DIGITAL BILLBOARDS

INSIDE TEXAS CITIES AND ETJS

SB 971 by Hinojosa and HB 1765 by Sid Miller

- · Overrides local ordinances and the will of the people to decide how their city should look. Over 250 Texas cities currently prohibit; many more strictly restrict the erection of new billboards; all would be superseded by these bills.
- · Delegates billboard control to a second state agency (currently TxDOT regulates billboards)
- Duplicates existing \$105 million State emergency/amber alert system
  - o Existing State-owned system has about 580 electronic signs on the ROW that effectively & ONLY display emergency, traffic and amber alerts.
- New, second system will be confusing, distracting and ineffective due to the location away from the highway ROW and constantly mixing emergency messages with commercial advertising messages.
- o New, second system will be privately operated by billboard companies creating potentially serious future security issues

#### · Bottom line---

- o These are NOT primarily emergency/homeland security billboards designed to assist the public. Instead they are primarily commercial advertising billboards designed and owned by the mulit-billion dollar billboard industry that leveraging fear to erect unnecessary jumbo-tron electronic changeable message TV screens throughout Texas cities and ETJs even if they are not wanted by the people who live there.
- o The billboard system is NOT needed since taxpayers have already invested \$105 million dollars to build 580+ TxDOT signs that are currently operating on the ROWs, along all evacuation routes and are effectively used ONLY used to display emergency information.


