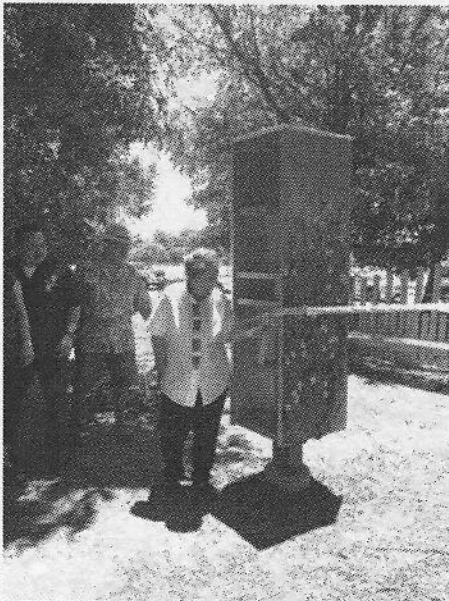


Birdie's Nook

May – June 2017

On Saturday, May 13, the family of Bertha Tamez held a ribbon-cutting ceremony in Monticello Park to open a little library built to honor their mother. The library, affectionately nicknamed "Birdie's Nook", was designed by Overland Partners. Overland was recognized by *Architect* magazine as one of the top 50 design firms in the United States in 2015 and one of the top 50 sustainable design firms in 2016. Inspired by the children's book, *The Giving Tree*, Overland Intern Coordinator (and Monticello Park resident) Ben Rosas set out in March to invest in the growth of the firm's aspiring architects, leading them through a small design-build project of a Little Free Library. This project was blessed to have the bright young minds from Overland, especially Jose Lizcano, Lance Brannock, and Brad Schaefer, as well as Italia, Nikhila, Fay, Aaron, Steve, Heath, Alyssa, Nat, and of course, Ben (who happens to be our son). They took this tiny seed of an idea and created this beautiful and meaningful structure that is so amazingly more than we could have ever dreamed or hoped. Without their passion, creativity, and all their hard work, this wouldn't be here today.

The idea for this project started about a year and half ago when I first heard about the Little Free Library concept. I immediately thought of my

mom, Bertha, because she is an avid and lifelong reader. Just a couple of weeks ago, I met her at the doctor's office and had to sneak a picture of her purse because she had two books inside! She is the reason I love to read. When we were kids, Mom would take us to the library all the time: the Westfall branch, the Bookmobile; anywhere there were books, she hauled us there. Maybe it was because we had to be quiet at the library; there were six of us, after all. And with six kids, there are inevitably squabbles and fights, and books were my escape. They showed me other worlds and other times.

Mom and Dad taught us right from wrong, and books like *To Kill a Mockingbird*, *The Chronicles of Narnia*, and *Lord of the Rings*

reinforced those values. Books were a refuge, but they became an inspiration and created a hunger to read more and learn more.

SHORT-TERM RENTALS

The City of San Antonio is beginning the process of evaluating Short Term Rentals. Currently, the City's Unified Development Code does not have guidance for short-term rentals operating in residential properties. A taskforce has been created to bring a balanced discussion on developing recommendations for an ordinance to City Council. Also, public meetings are scheduled after each taskforce meeting to present drafts section by section. All meetings are open to the public and will have time designated for citizens to be heard.

The City has been directed by Council to evaluate the following:

- Research if short-term rentals impact property values and neighborhood safety statistics
- Review how cities have updated municipal code or ordinances to allow this industry to operate
- Review options on how registering hosts with the City, and if a permit should be required
- Research if short-term rentals should be required to remit hotel occupancy taxes to the City
- Determine policies and procedures to enhance public safety in the short-term rental industry.

During the initial public meeting, the City confirmed individuals operating a short-term rentals are required to remit Hotel Occupancy Taxes to the City and State. While some might debate whether it should be paid it's currently state law and local ordinance. The City's Finance Department reported only 150 of the estimated 1100 short-term rentals operating within San Antonio are registered and paying the HOT tax. Penalties and interest can be accessed for unpaid taxes collected by the Finance Department: City of San Antonio (9%) Bexar County (1.75%).

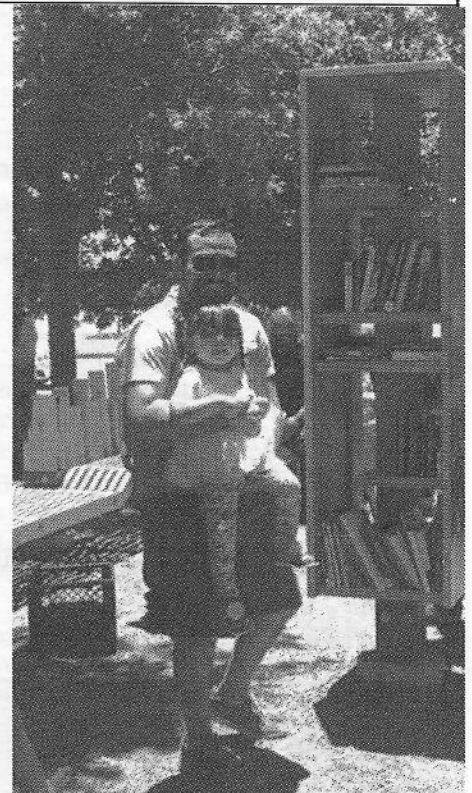

SIGN REVISIONS

MPNA voted during the March General Assembly to support the following additions to the City of San Antonio's Sign Revisions. The results were from stakeholder meetings over the past 18 months however, the stakeholders were out numbered by industry representatives. MPNA requested during the Council meeting on May 4th to support the following additions for Fredericksburg Road Protection, BOA opportunities, and additional Buffers. Unfortunately, NONE of the items were added as amendments by City Council.

The items requested:

- 1) The sign ordinance stakeholders recommended only retaining protection for Scenic Corridors which new billboards are not allowed to be erected and/or relocated to these designated areas. Once a billboard comes down, a new one may not be erected or relocated in a scenic or urban (Fredericksburg Road) corridor. The stakeholders recommended allowing new billboards to be relocated to Urban Corridors, Fredericksburg Road, in the new ordinance.
- 2) Handle unique requests for signage through board of adjustment instead of making them part of the code. This would allow neighbors and the public to comment. The new sign ordinance will allow exceptions in the code and eliminating a BOA opportunity.
- 3) No buffer exists for signage from adjacent property lines and therefore the recommendation in the sign revisions was for every 1' in height there would be a 1' in vertical buffer from a property line. MPNA joined others in requesting for every 1' in height there be 2' in vertical buffer to protect the community from illuminated signage and obstruction. The new sign ordinance adopted the 1:1 buffer scenario.

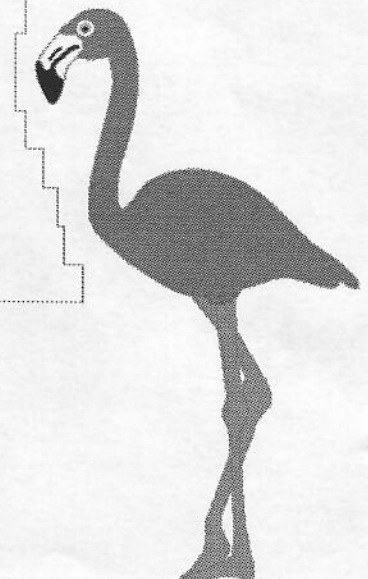

MEET THE NEIGHBORS

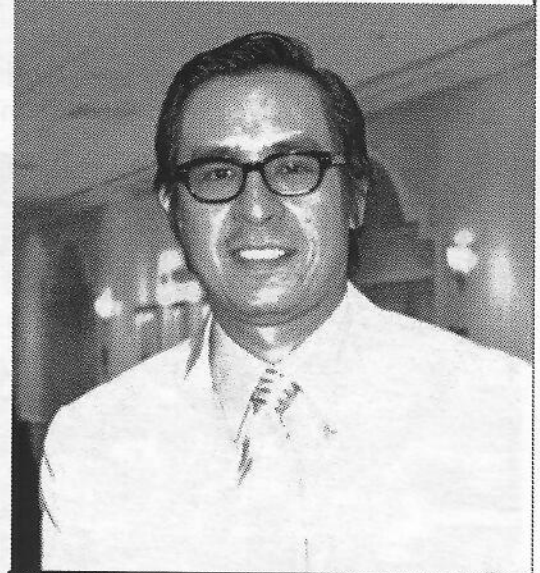
The San Antonio Film Festival is coming to town and Adam Rocha is excited. He is Director and his wife, Susan Ranjel is Producer, and this Mom and Pop non-profit is in its 23rd year of production in San Antonio. Ad where the offices? An address of 8452 Fredericksburg Road was given to this reporter, but that is only for mail. The real office is in the home of Rocha and Ranjel and their respective computers. Films come in through email. On top of it all, Rocha teaches at Marshall High School, full-time--Video Production, of course. So life is busy.

"We will produce a 32-page program a month and a half before the festival," Rocha said in a recent interview. The festival runs from August 1 through 6. The films will be shown at the Tobin Center for the Performing Arts. He said, "We don't have an advertising budget, so it is really word of mouth and our reputation." As to how many applications he has received, he said, "I don't know. They are still coming in. We have extended the deadline to May 26."

The genres of production include animation, narrative (Hollywood-type), documentary, and experimental. When asked who enters, he said, "All ages, beginning with teenagers and from all over. One year, a person from Yugoslavia entered and won a bicycle. But we didn't have money to ship the bicycle overseas, so he gave it away. Every year, it is different."

The festival is now at the Tobin, but here has it been in the past? Rocha said, "We travel around. Before the Tobin, it was on the Southside at City Base Cinema. But location varies. We have been at the Tobin for four years." When asked if he had shown any film that became well know, he said, "Last year, we featured 'Hell or High Water'. It became a big Hollywood film."

As a military child, Rocha grew up everywhere. When it came time for college and film school, Rocha said, "I felt I didn't have money for film school. So I decided I would get films produced through the students I taught." He added, "I have produced my own films, but mainly it is through my students. We enter contests and we win," he described the process of working with students. He said, "On the first day of class, I give them a camera and say, 'Now go make a film'" "It is a language and you learn it slowly. But kids are fearless at that age." He continued, "This is the art of figuring out who this person is and what they think." But what about censorship--in a school setting? Is he afraid that they will produce something that is too ??? He answered, "I do tell them not to get me fired."

He talked about his belief in his students. Having taught at Thomas Jefferson, Sam Houston, and Marshall, he has 14 years of experience on the subject. "I was that kid painting the garage," though he didn't actually do it. He said he thinks kids are kids wherever and they are good. "Knowledge is power," and he pointed his finger like a gun at the reporter and smiled.

Tickets can be purchased at SAFILM.com. The price is \$10-\$15 for a showing. The schedule will be posted sometime in the near future. So look up this site and find a film you would like to see. See you at the Tobin!


